The CGA association evaluates post-secondary courses for transfer credit in the CGA program. The Transfer Credit Schedule is prepared for information and guidance only. As course numbers and content change depending on the year of study, this schedule is subject to change without notice.

Transfer credits granted will be based on the Association's evaluation of the students' academic credentials. Students may apply for advanced standing by forwarding a completed Application for Advanced Standing to the CGA office, along with official transcripts of marks and a resume of any related experience. Where multiple university/college courses are listed for a CGA credit, all the courses must be completed. A minimum course grade of C+ is normally required for transfer credit, unless otherwise stated.
